**Meeting called to order at 3:02 p.m.**

**Ryan:** Our contract end date has not changed. With the holidays approaching, we will not see new operations starting in this schedule. Some of the ones that were planned are pushed towards the holiday season or beyond. We show no work on November 28-29 for the holidays. The main items on here are working on Turkey Lake Road and working in the loop ramp area. There are some other maintenance items and lighting work ongoing.

FDOT to Review past 7 days.

- i. Jack and bore under eastbound I-4 north of Sand Lake Road
- ii. Install bridge lighting (Area 1)
- iii. Install water main near westbound I-4 entrance ramp (Areas 1 and 2)
- iv. Bridge deck installation (Areas 1, 2, and 3)
- v. Turkey Lake median widening
- vi. Continue installing MSE walls (Area 1)
- vii. Excavate loop ramp (Area 3)
- viii. Install permanent drainage (Area 3)
- ix. Grade and sod around retention pond
- x. Maintain temp drainage (Areas 3 and 4)
- xi. Utility relocation
- xii. Ongoing mowing and litter pickup



**Ryan:** I spoke to Jim, and we should be receiving the new aerial image after the holiday. The only new item is the jack and bore operation on this schedule. This is where the jack and bore began this morning (shows map). All the work is underground and does not impact motorists. We plan to do this on Sand Lake Road to limit diversions.

**Ryan:** Placing lime rock is the only new work item that is on this schedule. This is a good sign because that is the base material before we start laying asphalt. That means we are making great progress.

It was a very positive meeting.
