Meeting called to order at 3:03 p.m.

We are working on Turkey Lake Road and then we have our typical work that is happening in the loop ramp area. We have bridge work and work on I-4 that is ongoing. Nothing new to note.

We are dumping a lot of traffic in that intersection.

Ryan: That would be on International Drive?

David: Yes, they make the right and block the ramp to get on I-4. That is consistent.
